## Qualification

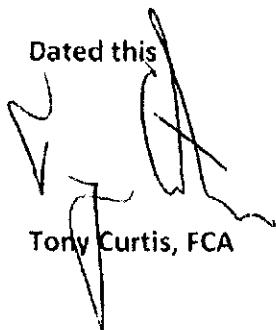
